Our Council Our Voice — Driving cultural change

was the theme of the NCWA Midterm Conference held 14 June, - 16 June: at Rydges Capital Hill, Canberra, ACT.

NCWSA delegates present were Dr Wendy Abigail, Mrs Maureen Oborn and Ms Margaret Flint OAM.

Wednesday 14 June was a workshop day for the National Council of Young Women of Australia (NCYWA).

That afternoon in Wesley Hall, Forrest, NCWA members from Constituent Council met for a business session, which was opened by Barbara Baikie, NCWA President. Sessions included discussion on the Standing Committee Structure, Advocacy Training led by Dr Wendy Abigail, Flinders University SA/ NCWSA and strategic planning.

Thursday 15 June commenced at Parliament House with breakfast and the launch of NCYWA.

Resolutions were considered at the morning NCWA Business Session at Rydges, the conference venue.

Catherine McGrath was an impressive and effective MC throughout the two conference days. In the absence of Her Excellency Lady Cosgrove, Patron of NCWA due to illness The Governor General, His Excellency the Honourable Sir Peter Cosgrove AK MC (Retd) welcomed delegates.

During the afternoon *Vulnerability of Older Women, Focus on Poverty and Homelessness* was the theme. Following the speakers there was small group discussion and presentations of solutions.

Vulnerability of Younger Women and Violence against Women was the theme for Friday 16 June. Small group discussion and presentations of solutions concluded the day's deliberations. and conference.

Elder Abuse

Since 2002 when it was announced at the *Toronto Declaration of the Global Prevention of Elder Abuse*, preventing elder abuse is 'everybody's business'. High rates of abuse in high and middle income countries ranges from 2% to 14% according to the World Health Organisation. Here in Australia we have a growing elderly population where the incidence of elder abuse will potentially increase. In light of this, the government commissioned a report which is now available for reading.

The report makes 43 recommendations for law reform to look after our older people by:

- improved responses to elder abuse in residential aged care;
- enhanced employment screening of care workers;
- greater scrutiny regarding the use of restrictive practices in aged care;
- building trust and confidence in enduring documents as important advanced planning tools;
- protecting older people when 'assets for care' arrangements go wrong;
- banks and financial institutions protecting vulnerable customers from abuse;
- better succession planning across the selfmanaged superannuation sector;
- adult safeguarding regimes protecting and supporting at-risk adults.

The Framework provides high level guidance to enable all levels of government and health professionals to develop future policies, actions, strategies and services to work towards delivery of a more effective and coordinated national response to chronic conditions and their risk factors. This will improve the health and wellbeing of individuals, and deliver a more sustainable health system. The Framework is available at www.health.gov.au.

Thank you for your valuable contribution to the development of the Framework. Input was received from a broad range of stakeholders including state government, Aboriginal and Torres Strait Islander health organisations, universities, peak bodies, health professional and non-government organisations, industry, clinical experts, and consumer groups, as well as from those living with chronic conditions and their carers. All of the input received was invaluable and greatly appreciated.


