Students use own insect repellent and apply before bushwalk starts. Students with allergies to bites bring own medication/EpiPen.
Using lookout	Year group / stage specific	Guiding experience	fall off lookout	AUSECO instructor leads at a steady pace and identifies safe boundaries from edge. Students are warned of potential risk and instructed to stay seated at unfenced lookout.
Excursion location	Any	Guiding experience, first aid training	bad weather / bush fires	If weather conditions are particularly hazardous a decision on whether or not to proceed will be made in consultation with the teachers / school.

Exposure to sun	Any	Guiding experience	sunburn / sunstroke	Students are reminded to apply sunscreen, wear hats and drink water. Any available shade is utilised.
Crossing roads & carparks	Any	Guiding experience	hit by car or trip on road / kurb	Students will cross in supervised groups with warnings about crossing safely, quiet roads where possible.
